

## RSNA DIAGNOSIS LIVE™ TERMS OF USE

Last Revised – April 2015

Welcome. These Terms of Use (“Terms”) apply to the use of websites and/or portals which are owned and/or operated by or on behalf of the Radiological Society of North America and provide information and services related to RSNA Diagnosis Live™ (the “Site”), through our authorized third parties, or by any of the other means described herein.
